Paper 1 – Literature & Social History

 $8 \times 2 = 16$

- 1. Explain in an essay of about 500 words the transition in Europe and England during the sixteenth-century Renaissance that has come to exemplify the 'early modern'.
- 2. How did the English experiment with political democracy in the seventeenth century affect literary activity in England? Give a general outline in an essay of about 400 words.

Paper 2 – Poetry 1: Chaucer to the Neoclassical Poets

1. But, to say something of her moral sense,
She was so charitable and piteous
That she would weep if she but saw a mouse
Caught in a trap, though it were dead or bled.
She had some little dogs, too, that she fed
On roasted flesh, or milk and fine white bread.
But sore she'd weep if one of them were dead,
Or if men smote it with a rod to smart:
For pity ruled her, and her tender heart.
Right decorous her pleated wimple was;
Her nose was fine; her eyes were blue as glass;
Her mouth was small and therewith soft and red;
But certainly she had a fair forehead;
It was almost a full span broad, I own,
For, truth to tell, she was not undergrown.

- a) Explain the lines given with reference to context . (5 marks)
- b) Explain how Chaucer uses rhetorical devices to make his point. (5 marks)
- c) What makes Chaucer assume that his reader will respond to his use of irony? (6 marks)

<u>Paper 3 – Fiction 1: The Novel in the 18^{th} and the 19^{th} Centuries</u> $8 \times 2 = 16$

- 1. Attempt to highlight the satirical significance of the title of Jane Austen's novel, *Persuasion*. (8 marks)
- 2. Moll Flanders' guilt is more convincing than her repentance. Do you agree? Give textual reasons for your answer. (8 marks)

Paper 4 – Non-fiction

- 1. Would you agree that Addison successfully uses a fictional figure as a commentator on the non-fictional world as part of a tradition of 'realism' which insisted on 'universals' and which emerged from the Enlightenment? (8 marks)
- 2. Show how Virginia Woolf's major concerns in her essay, 'How It Strikes a Contemporary', lie with a cultural crisis,. (8 marks)

Paper 5 – Theory I: Classical & Neoclassical Critical Theories $8 \times 2 = 16$

- 1. In what sense can Longinus be called a 'romantic' critic? Give a textual argument. (8 marks)
- 2. Explain the neoclassical concept of "wit". (8 marks)
