

Frequently Asked Questions(FAQs)

GUCDOE

1. Who is eligible to pursue PG Programme at GUCDOE?

Ans-

- **M.A Programmes:** Graduate from a recognized Indian or Foreign university in any discipline irrespective of the percentage of marks and subjects offered.
- **M.Com Programme:** Graduate from a recognized Indian or Foreign university in any discipline irrespective of the percentage of marks and subjects offered.
- **M.Sc.-IT:** B.Sc. (With Computer Science as the Major or General subject) or BCA/B.Sc. (IT) or B.E./B.Tech. (CSE/IT) or B.Sc. with PGDCSA/PGDCA degree from a recognized Indian or Foreign University.

2. When can a candidate take admission in any programme in GUCDOE?

Ans- The admission process for new academic session is generally held from July to September and January to March or as notified by the UGC-DEB.

3. Are all Programmes of GUCDOE approved by the UGC-DEB?

Ans- Yes, all the PG Programmes offered by GUCDOE are approved by the UGC-DEB.

4. Whether the Degrees offered by the GUCDOE is equivalent to the degree offered in conventional mode?

Ans- Yes, all the degree offered by **GUCDOE** are equivalent to those offered in the regular mode. Please visit www.ugc.ac.in/deb for further clarification.

5. Whether I shall be eligible for State and Central government as well as PSU Jobs after completing a programme here?

Ans: Yes, you will be eligible for government and PSU jobs after securing a degree at **GUCDOE**.

6. Can I appear for NET/SLET and M.Phil /PhD Programme after completing my PG Programme at GUCDOE?

Ans: Yes, you will be eligible to appear for **NET/SLET**. You will also be eligible to appear **M.Phil/PhD** entrance test conducted by various Universities, provided you obtain minimum norms for appearing such exam/entrance.

7. Can I avail the facility of attending counselling classes after having enrolled in a programme at GUCDOE?

Ans: Yes, you can attend counselling classes after having enrolled in a Programme at **GUCDOE**. All the information regarding the commencement and the schedule of the counselling class will be published in our website.

8. Is it mandatory for attending such Counselling classes?

Ans: No, it is not mandatory to attend such counselling class, but 75% attendance is required

9. Can I contact the respective faculty member(s) of GUCDOE for individual academic counselling?

Ans: Yes, you can contact and personally consult with the respective faculty member at **GUCDOE** during the office hours of the working days for discussing academic matters and any other related issues.

10. Shall I be provided with Self-Learning Materials (SLM) for self-study after admission?

Ans: Yes, you will be provided with SLMs for self-study after admission.

11. Does the institution have separate Library facility exclusively for the distance learners?

Ans: Yes, **GUCDOE** has a separate library with books, journals, newspapers etc and internet connectivity exclusively for the learners of the institution.

12. Is there any age restriction in joining programmes offered by Distance Education?

Ans No, there is no age restriction for admission, provided that a minimum qualification required for admission is to be fulfilled.

13. Is it necessary for Distance Education learners to visit University Campus for studying?

Ans. Not always required. Learners have the flexibility to study from home or any location that suits them. Nevertheless, specific programs mandate practical sessions or similar activities, necessitating Learner attendance **GUCDOE** or designated PCP Centers for theory classes, practical courses, labs, or units spanning approximately 2-3 weeks.
